  - a. Certificate of Good Conduct
  - b. Clearance Certificate from CRB
  - c. Clearance Certificate from HELB
  - d. Tax Compliance Certificate from KRA
  - e. Clearance Certificate from EACC
2. Be a resident of the area served by the Water Company
3. Degree in Business Related course ,CPA-Experience in accounting/ finance and must be in good standing at the Institute Of Certified Public Accountants of Kenya and produce testimonials to that effect  
**OR**  
Degree in Engineering –Experience in civil, Agricultural, Mechanical, Environmental, Electrical or water supply systems, must be registered and nominated by their professional body and produce testimonials to that effect.
4. Demonstrate experience as a Change Management Agent with acumen in a business or any profession of at least 7 years.
5. Must **NOT** be suppliers or other trading associates of the Company
6. Must **clearly state the Category** he or she is applying for.
7. Must attach a **letter of nomination** by the Stakeholder Group or Institution to which they belong
8. Attendance of Corporate Governance training is an added advantage.
